### **COURSE DESCRIPTION**

Since knowledge has been identified as a major factor of production, several Southeast Asian governments have embarked on strategies to develop a knowledge society and a knowledge-based economy. The race for competitive advantages is shifting from a natural resources and industrial production base to a knowledge and information base. Producing and selling knowledge is seen as a key factor in public as well as corporate development strategies. The course will stress knowledge management as part of national and international public policy, as knowledge governance. Case studies of selected Asian countries (mainly Singapore and Malaysia) and of international organisations will form the backbone of the course. The cultural preconditions and effects of knowledge governance will be discussed and the strategies of the Singapore and Malaysian governments in this respect analysed.

#### **PREREQUISITES**

#### REQUIREMENTS

(1) Individual Writing Assignment:

Preparation of a summary of up to 2 pages of one reference (journal article, chapter in a book or website) and presentation in class (slides).

(2) Group Project – KM/KG Strategy of one country and organisation of a K-Forum (agenda will be explained in class). Groups of max. 5 students will undertake an in-depth examination of KM strategies and their results in Singapore, Malaysia or another Asian country or an international

organization based on library and internet research and present the results in class (slides or video). A paper of less then 20 pages per group is required. A video with a video script may be submitted instead.

OR

Groups of max 5 students will prepare a brief (1 page each or slides) on a selected issue for a debate in a "Knowledge Forum" and submit an executive summary of the debate of about 10 pages the following week.

The course instructors will be available for intensive consultations in person or through e-mail.
